

Section E: Residential Follow-Back Calendar. (Separate Sheet)

Interviewer documents the history of housing in the subject's life since the last interview. Determine if hospitalizations were for medical, psychiatric, or detox/rehab reasons. Watch for periods of homelessness and brief residential transitions. Interviewer fills in the names of the months since the last interview to orient the subject to the time period involved. Interviewer makes notes on the calendar to show the residential history of the subject.

Now I want you to think about where you have been living since the last interview (give date). We are interested in all of the places where you've stayed during this time, including hospitals. Let's look at this calendar together, and I'll make notes as you talk. This is (month) (year), so the time we'll be talking about is between (give date of last interview) and today. O.K. Let's begin. Why don't we start with where you are living now and work backwards from there, month by month.

After the subject has provided the initial information, the interviewer should use the list of prompts on the calendar to probe for residential situations not already recalled by the subject.

Now I want to read you a list of living situations, and I want you to tell me if you have been in any of these, even if only for one night.

Section F: Living Situation

F.1 Residential History: *Interviewer builds chronological record of subject's residential history (including institutionalizations and temporary situations) since the last interview, using the Residential Follow-Back Calendar and seeking verification from the subject. For each residence (or lack thereof), record: 1) the location, 2) the type of residence (use housing categories list from Residential Follow-back Calendar), 3) the dates, as accurately as possible, 4) with whom the subject lived (in terms of relationships, no names), 5) why the subject moved (in subject's words), 6) who paid for the housing (including subsidies such as Section VIII), and 7) the cost of the housing (if known). Note: For hospital, jail, crisis center, or family and friends overnight, ask WHY ENTERED, not why left (#5).*

Based on what you've just told me about where you've been living, I need to record each place you've lived and ask you a couple more questions about each. I know we just talked about this, but now I need to start again with where you live now and work back to where you lived on (give date of last interview), listing each place you've lived.
